Controls are reviewed regularly through management system reviews.

## **Third-Party Risk and Due Diligence**

We apply a proportionate, risk-based approach to third-party supplier management.

Our supplier base includes:

- Cloud hosting and infrastructure providers
- Software and technology suppliers
- Professional and support service providers

Due diligence activities include:

- Supplier selection based on compliance and reputation
- Contractual compliance obligations
- Ongoing supplier performance monitoring
- The right to remediate or terminate relationships if ethical concerns arise

The inherent risk of modern slavery within our direct operations is assessed as **low**.
